## 1 THE SKILLS FOR SUCCESS FOR CAREERS IN THE SKILLED TRADES AND TECHNOLOGY

The Government of Canada has updated the previous Essential Skills framework to the new Skills for Success model in response to the evolving labour market and changing skill requirements. This model outlines nine fundamental skills Canadians need to thrive in work, education, training, and daily life.

Skills/Compétences Canada aims to highlight the importance of these skills, vital for success in trade and technology careers. Competitors can see how Skills for Success are integrated into contest descriptions, projects, and project documents. Recognizing these skills during the competition helps competitors match tasks with specific skills necessary for success and understand how these skills apply within their trade or technology programs and future careers.

The nine key Skills for Success, validated for workplace success, are:

- 2. Communication
- 3. Collaboration
- 4. Adaptability
- 5. Reading
- 6. Writing
- 7. Problem Solving
- 8. Creativity and Innovation
- 9. Digital

This competition aims to showcase and elevate the skills, creativity, and professionalism of aestheticians. It provides a platform for participants to demonstrate their expertise in various beauty treatments and techniques, such as facials, manicures, body treatments and makeup, fostering a spirit of excellence and innovation within the industry. Through rigorous assessment by industry experts, these competitions not only celebrate outstanding talent but also set high standards, inspire continued education, and highlight emerging trends. Ultimately, they contribute to the advancement and

recognition of the beauty therapy profession while demonstrating professionalism and complying with occupational health and safety.

# Advanced Facial<sup>2,7</sup>

The competitor will showcase an advanced facial routine, featuring the application of cleanser, exfoliant, serum(s), mask and finishing products (Sponsor L'Moor).

The facial treatment will utilize equipment such as the BT Sonic for cleansing (<u>click here</u> <u>for video</u>) and BT Micro for product infusion (<u>Click here for video</u>). Cold globes used at competitors' discretion, any way they choose.

Participants will demonstrate lymphatic drainage techniques on the face, followed by a relaxing massage covering the face, neck décolleté and neck & shoulders. Video link on SCC website.

# Manicure: Seasonal Fusion<sup>2, 4, 8</sup>

During the Seasonal Creative Manicure, competitors will showcase their skills by performing a dry gel polish spa manicure, which includes shaping the natural nail and performing cuticle work. They will also apply an exfoliation treatment and a mask and demonstrate a comprehensive 12-step hand and arm massage. Detailed instructions for this massage is available on the SCC website for reference.

Competitors are required to apply a bold red gel polish to nine fingers, leaving one ring finger unpolished. On this ring finger, they will create a hand-painted nail art representation of one of the seasons—spring, summer, autumn, or winter—without any three-dimensional decorations. The design will continue from the ring finger, across the back of the hand, and along the forearm up to the elbow, using any chosen art medium. All artwork must be hand painted and free from any embellishments. Competitors are responsible for supplying their own tools and materials for the freehand nail, hand and arm design.

## **Body Therapy Treatment**<sup>2,3,5,6</sup>

Competitors will perform a manual leg and foot exfoliation from the knee down, including the entire foot followed by a mud detoxification wrap to the exfoliated area finishing with a lotion.

During the detox wrap, competitors will perform a pressure point head massage (see video on SCC website) followed by a jade comb head massage (link to video 0:00-1:53 found here).

Competitors will then complete a dry (no soaking) mini pedicure on a lay down bed which will include toenail trimming, filing, and cuticle work with a French lacquer polish (base coat, white French application that compliments the toenail shape, blush pink overlay, top coat). Corrections are permitted. Polishes to be supplied Sponsor- LCN Pro Beauty.

## Creative Makeup: Seasonal Fusion<sup>2, 7, 8</sup>

In the seasonal fusion creative makeup challenge, competitors will use their own makeup and tools to create a unique design. The task is to blend the essence of two chosen seasons onto the face and décolleté, with equal representation of each season (50/50 split). Competitors may choose any two seasons for their design.

Judging will focus on creativity, technical skill, color harmony, theme representation, and overall impact. Competitors should aim to create a memorable fusion of two seasons, using two accessories to enhance their design.

One of the objectives of SCC is the sustainability of the competition. As a result, the toolbox brought by competitors will be restricted to the following maximum specifications:

The competitor toolbox must not exceed a carry-on size suitcase. There is no exception to this rule. If the competitor toolbox is larger than what is indicated, the competitor with the guidance of the NTC, will need to remove items from the toolbox and those items will not be used during the competition. All tools must fit inside one toolbox. Tools outside of a toolbox will not be permitted.

## 4.3 Required clothing provided by the competitor

- Black scrub uniform (see sample below). NO leggings.
- Black non-slip flat or low heel, professional closed toed shoes.
- Black socks must be worn
- No jewelry.
- Hair must be tidy and tied back and off the collar and face
- Competitor mush have short, manicured, non-polished nails

# 5 HEALTH AND SAFETY

#### 5.1 Safety program

SCC has implemented a comprehensive safety program as health and safety is an integral part of our competitions. Our safety program includes guidelines and procedures to make the work environment in each skill area safer.

## 5.1.1 Safety manual

As part of our program a safety manual has been created to monitor and document health and safety within each skill area. It includes a definite plan of action designed to prevent accidents. The safety manual will be provided for every skill and these instructions must be followed and respected by all participants and officials at the SCNC.

## 5.1.2 Safety workshop

During orientation, competitors will participate in a safety workshop and they will be expected to work and maintain a safe working area during the competition. Any competitor breaking any health, safety, and environmental rules, may be required to undertake a second safety workshop, this will not affect the competitor's competition time.

## 8.2 Ties

- Tiebreaker #1: In the event of a tie, the candidate with the highest score in the Advanced Facial criteria will be declared the winner.
- Tiebreaker #2: In the event of a second tie, the competitor with the highest score in the Body Therapy Treatment criteria will be declared the winner.
- Tiebreaker #3: If a tie still remains, the competitor with the highest score in the Creative Makeup criteria will be declared the winner.

## **8.3** Test Project change at the competition

Where the Test Project has been circulated to competitors in advance, NTC (National Technical Committee) members can change a maximum of 30% of the work content. Please refer to the competition rules (Refer to 8.4).
